Staff Recommendation:	Brandon Chasen  Eddie Leon and Eric Holcomb  Approve height, massing and scale with final design to return to full commission.  In addition, staff suggests the following guidance for final design  • Through design elements break up the massing of proposed building along South Dallas Street. The stepping down of height along South Dallas St. ca resemble the stepping down of many rowhouses structures at the corners of alley streets. The setba break up this elevation into three parts. This elevation should be treated as three components of single whole.  • The main elevation that faces Eastern Avenue should be treated as a single whole with a base, middle, a top. It should also follow the rhythm of many of thistoric rows in Fells Point. Therefore, the design should visually break up the facade into vertical components but allow the main entrance to be east recognizable.  • Explore increasing the setbacks from 10 feet to 12 feet in order to complement the rhythm of historic blocks found in the district.  • The Eastern Avenue façade needs further depth and dimensionality. Use window reveals and architectural elements to create shadow lines in the design.  • Use proportions of solids and voids that complement the historic character of the district.  • Materials of the design need to complement the masonry (brick) look of the historic district.
